I. General information regarding processing of personal data

3. Processing of personal data

C&A respects your privacy and is very serious about guarding the security of your personal data.

"Personal data" means all information that can be used to identify you, as natural person, i.e. name, IP address, contact details or user behavior.

In section II. of this privacy statement, we will inform you about the actual scope of processing your personal data when accessing our website. Your personal data will only be processed if and insofar this is required to ensure the functionality of our website and to allow availability of the content. Any further use of your personal data will only be done with your prior permission. For exceptional and justified cases where it is not



possible to obtain you permission in advance, your personal data will be processed in accordance with the provisions of the EU General Data Privacy Regulation (GDPR), and all other relevant national data protection laws.

4. Rights of data subject

You, as data subject, have the right to information towards C&A pursuant to Art. 15 GDPR, the right of correction under Art. 16 GDPR, the right to erasure under Art. 17 GDPR and the right to restriction of processing under Art. 18 GDPR. Furthermore, pursuant to Art. 20 GDPR, you have the right of data portability (access to data in a machine-readable format) for data which is stored under the legal base of consent.

The data subject may assert the right to complain that the processing of personal data concerning them is contrary to the GDPR (Article 77 GDPR) with a supervisory authority in the Member State of his or her residence, place of work or place of alleged infringement. You have the right to object under Art. 21 GDPR and you may withdraw your consent at any time. This also applies to consents already granted prior to the entry into force of the GDPR. The revocation of consent does not affect the legality of the personal data processed until the revocation.

Insofar your data is processed on the legal basis of legitimate interest as stated below, you shall have at any time the right to object processing of your personal data, on grounds relating to your particular situation. C&A shall no longer process the personal data on this legal basis unless we demonstrate compelling legitimate grounds for the processing which overrides your interests, rights and freedoms or for the establishment, exercise or defense of legal claims. The storage or processing on other legal bases also remains unaffected by your objection.

II. Processing of personal data on our website

1. Automatic Storage for the creation of log files

If you access our website, our webservers automatically collect information provided your browser. This information does not contain personal data but only information regarding

- IP address of your device
- timestamp of your server request (date and time)
- content of your request
- type and version of your browser
- browser settings (i.e. language)
- operating system of your device
- the website you came from
- the websites, you access from our website

This information is stored automatically in our log files.

In accordance with Art. 6 I (f) GDPR, C&A has a legitimate interest in processing the information provided by your browser in order to ensure the functionality of the website and to make the content available. Furthermore, the temporary storage of log files allows C&A to improve attractiveness, content and usability of the website.

C&A deletes the data as soon as the purpose of processing is fulfilled, but latest 31days after you have visited our website.

To allow access to and operation of the website it is mandatory to collect and store the aforementioned data. As a result, you do not have the right to object processing.

2. Cookies on our website

C&A uses cookies on its websites. Cookies are small files that are stored in your browser or directly on your device and contain specific settings and data that allow our system to identify your browser when you access the website the next time. Storing cookies helps us to arrange the content and to improve performance of our website.

Essentially, a choice is made between two different types of cookies, so-called "session cookies" that are deleted as soon as your browser closes and "persistent cookies" that remain stored on your device for a longer period of time. You can delete existing persistent cookies at any time from your browser/device.

2.1. Technical required cookies

On this website we use cookies that are technically required for the provision of this website and its features. Some elements on our website require an identification of your browser, although you moved to other sites in the meantime. For this reason, the following data will be collected and stored in the cookies:

- Language settings
- Log-file information

Please note that the collected data will not be used to create user profiles.

In accordance with Art. 6 I (f) GDPR, the legal basis for this processing your personal data in connection with cookies that are technically required, is the legitimate interest of C&A to allow the technical provision of the website and its features. Furthermore, C&A uses these cookies to make the visit of the website as convenient as possible for the website visitor.

2.2. Analyses Cookies / Web Tracking

Apart from these cookies, we also use cookies and tracking Pixel that are technically not required for the provision of the website but can be used to track and analyses the behavior of website visitors.

The data collected in the cookies, will be stored in a pseudonymous form and is linked to a cookie identification number. This identification number will not be assigned to your IP address nor merged with other personal data. Consequently, it is not possible for C&A to identify a certain data subjects, but for instance the visited pages of the website and the duration of the visit.

If you visit the C&A website for the first time with a device, you will be informed about the use of cookies and tracking pixel with the following notification

You consent to the use of cookies and tracking pixel by continuing browsing on this this website.

Depending on the settings, your browser automatically accepts the storage of cookies. You have the possibility at any time to configure storage of cookies in your browser settings, for instance you can refuse storage of third-party-cookies or all kind of cookies. Please note that refusing the storage and processing of cookies might have a negative effect on usability and performance of our website.

Google Analytics Cookie

C&A uses Google Analytics on this website. Google Analytics is a web analyses service from Google LLC. (1600 Amphitheatre Parkway Mountain View, CA 94043. USA; hereinafter "Google") which uses cookies, that are saved on the user's computer and allow analyzes of the use of the website. These cookies track the following information:

- the time you stay on our website
- actions you take



- the websites you came from and
- approximate location
- IP address.

The information generated by the cookie is usually transferred to a Google server in the USA and stored there. On this website, IP anonymization is activated, so that your IP address within member states of the European Union or other contracting parties to the Agreement on the European Economic Area is abbreviated (cancellation of the last eight digits) before being transferred. In exceptional cases only the full IP address is transferred to a Google server in the USA and abbreviated there. The IP address transferred from your browser within the context of Google Analytics is not merged with other Google data. Legal basis for the use of Google Analytics on our website are Art. 6 I (f) GDPR. C&A's legitimate interest to analyses your user behavior on this website to increase efficiency and performance of the website and to make it more attractive and user-friendlier for the users.

For the exceptional case where your personal data will be transferred to a Google server in the USA, Google is subject to the EU-US-Privacy shield, https://www.privacyshield.gov/EU-US-Framework.

You may withdraw your consent to store cookies on your device at any time by changing the settings of your browser. Please note that in this case you might not be able to use the full functionality of our website.

Adobe Analytics web tracking cookie

The C&A website uses Adobe Analytics, a web analysis service (online targeting) operated by the Adobe Company. Adobe Analytics uses cookies and so-called tracking pixels, which are called up from your computer or stored there and enable an analysis of your use of and navigation on our website (so-called session information). These cookies and tracking pixels allows analyses of surf behavior in anonymized form. Thereby, we can for example generate statistics showing, which pages of our website are particularly popular or how many users visit certain pages of the website, what cities website visitors come from, what type of browser and operating system the website visitor uses and what pages of the internet presence he visited.

The session information collected in this way is transferred to an Adobe Analytics server within the EU, where it is stored and further processed. Based on this information, Adobe Analytics analyzes the session information of your visits to the C&A website using this device in order to compile reports on your activity on the website C&A. If necessary, Adobe shall also forward this information to third parties, insofar as this is legally prescribed or insofar as third parties process this data on behalf of Adobe. Adobe will not link the IP address of your computer to other Adobe data under any circumstances.

In any case, the data collected in this way cannot be used to identify visitors of this website personally. The collected data is only used to improve the website. Because of this, all IP addresses are abbreviated, so that IP addresses are only processed in anonymized form. No other use or forwarding to third parties takes place.

Legal basis for the use of Adobe Analytics cookies on our website are Art. 6 I (f) GDPR. We use the reports to increase efficiency and performance of the website and to make it more attractive and user-friendlier for the users.

You may withdraw your consent to store cookies on your device at any time by changing the settings of your browser.

Adobe gives you the opportunity to control our options for using session information, which is used by the cookies placed by the Adobe Analytics domains 207.net and omtrdc.net. Adobe Analytics is operated via these domains, which evaluate the cookies placed on your computer and provide that information to us.

If you do not want Adobe Analytics to collect session information about your visit by using your computer, you can object to this using the https://www.adobe.com/be_en/privacy/opt-out.html.

You can also deactivate the analysis of your usage behavior by Adobe in general by downloading and installing a deactivation add-on offered by Adobe. With your objection exercised in this manner, no further data about your usage behavior will be stored when visiting our website using this computer and this browser and the existing stored data will not be further used. Please note that the right of objection is also exercised by storing a cookie on your computer. This cookie only contains the information that you have objected to the use of the data. The opt-out is thus only effective if and for as long as cookies are accepted by your browser. If an opt-out-cookie is deleted, it is no



longer possible for us to recognize or observe your objection. You must allow such cookies to remain stored on your computer so that your objection is permanently activated. If you delete the opt-out cookie, you have to perform the opt-out again. You also have to perform the opt-out for every computer and every browser used by you.

Facebook Pixel

C&A uses conversion tracking pixel (Facebook Pixel) operated by Facebook Inc., (1601 Willow Road, Menlo Park, California 94025, USA) on this website. The use of Facebook Pixel allows analyzes of user behavior on our website and displaying interest-based advertisements on Facebook (Facebook Ads). We use Facebook Pixel to show our Facebook Ads only to users who are interested in our products or who show other relevant attributes that we submit to Facebook (Customer Audience). Furthermore, we may use Facebook Pixel to track media penetration of our Facebook Ads (Conversion tracking).

In case you visit the C&A Blog Facebook pixel stores cookies on your device. These cookies collect data, such as log file information, Pixel ID and track your surf behavior.

For C&A the collected data is anonymous and will not be assigned to other personal information which would allow an identification of your person.

However, the information generated with Facebook Pixel may be transferred to Facebook servers in the USA and stored there. Wherever personal data is transferred to Facebook servers is the USA, Facebook is certified and subject to the EU-US-Privacy shield, https://www.privacyshield.gov/EU-US-Framework. In case you are a registered Facebook member and depending on the privacy settings of your Facebook account, Facebook may assign the information generated by Facebook Pixel to your user account and use this information for own purposes. Although you do not have a Facebook account or you are logged out from Facebook your data will be collected and stored on a Facebook Server in the USA. Legal basis for C&A's use of Facebook Pixel and Customer Audience is Art. 6 I (f) GDPR. C&A has a legitimate interest to display Facebook Ads to our customers and to analyses user behavior of our customers to allow optimization and economic operations of our online business. The information received via Facebook Pixel is used by C&A for statistical analysis and market researches only.

If you do not want Facebook to collect data by Facebook Pixel and to display Facebook Ads to you, you may object to this at any time by changing the privacy settings of your Facebook account. These settings are linked to your account and apply to all devices you use to access Facebook. If you have no Facebook account you can prevent collection of your personal data by

If you follow the links on our website whilst you are logged in to your user account of the social network, information concerning your visit to our website will be transferred to the servers of the social network and stored there. The provider can assign your visit to our website to your user account and may be published in the social network to your account. This information will be visible for your contacts. To prevent this, you must log out of your account before clicking on the icon.

Functionalities attached to social network links, in particular the transfer of information and user data are not automatically activated when accessing our website, but are only activated upon clicking the icon.

4. Google maps

Furthermore, you can search for certain stores by entering a Zip-code or city. When you accessing the store finder you are asked to share your location. To find stores in your location the following data may be transferred to a Google server in the USA to analyses your position.

- the location data from your browser settings or your mobile device
- IP address

On this website, IP anonymization is activated, so that your IP address within member states of the European Union or other contracting parties to the Agreement on the European Economic Area is abbreviated (cancellation of the last eight digits) before being transferred.

In case you are logged into your Google account, Google may assign your store research to your account. If you do not want Google to connect this event with your account, you may logout before using the store finder.

C&A deletes your data as soon as your request is answered.

Please note that we cannot communicate further in case you withdraw your consent. In this case, C&A will delete all personal data that we received and stored in the course of your contact.
